- Mr. Long recognized the stations listed above for their achievements and other accolades, as well as highlighting the work they do throughout the year.
- Mr. Shealy said they were glad to have all of them at the meeting, and they appreciated them. He said he doesn't think many people realize what it takes to be a volunteer firefighter/first responder, the amount of time to earn their qualifications, time away from their families to support their community. He said he commends all of them and thanked them for what they do.
- Mr. Smith thanked Mr. Long for putting this together and that they
 have been discussing doing this for a few months. He said it was long
 overdue to get volunteers together and thank them and let residents
 know what resources the county has. He said the county could not
 have their services without the volunteers and they appreciate them,
 and they are behind them.

- Mr. Johnson said he has had the honor and privilege to work with many of the volunteers. He said he travels the state and most people in public safety are blown away when he tells them they still run on a volunteer basis, but he said it is because of amazing people like the volunteers in attendance. He said he thanks God for them; he thanks God for what they do for the county, and he knows they can't do everything, but he wanted them to know that they are loved, prayed for, and supported and they will do everything in their power to show that they are with them 100%. He thanked God for each for them.
- Mr. Sease thanked the volunteers for the time they spent on calls, training, meetings, just to get that small tax break. He said Newberry County and its residents thank them for all they do.
- 4. Ordinance No. 05-01-2025. An Ordinance authorizing the execution and delivery of a fee agreement by and between Newberry County, South Carolina and Newberry PV1, LLC providing for a payment of a fee in lieu of taxes, providing special source revenue credits, and addressing other matters related thereto.
 - a. Third Reading.
 - Mr. Smith made a motion to accept third reading; Mr. Sease provided the second and the motion carried 6-0.
- 5. Ordinance No. 05-02-2025. An Ordinance to provide appropriations for the Fiscal Year beginning July 1, 2025, and ending June 30, 2026, for the Newberry County budget for County Ordinary purposes and for other County purposes for which the County may levy a tax and receive revenues; to provide for the levy of taxes on all taxable personal and real property in Newberry County for all county purposes, including sufficient tax to pay the principal and interest on outstanding indebtedness of Newberry County payable during said fiscal year; to provide for matters relating to Newberry County; and to provide for the expenditure of said taxes and other revenues received by the county during said fiscal year,

and to provide for borrowing in anticipation of tax collections by the issuance of one or more tax anticipation notes, if necessary.

a. Third Reading.

- Mr. Shacker said the budget is unchanged from the previous readings. This is a \$94.7 million budget, \$50.7 million is associated with the capital projects fund, the bulk of which are the CPST projects. Mr. Shacker also mentioned that the General Fund budget is proposed at \$39.8 million a 1.5% decrease compared to the current fiscal year and there are no tax, fee, or service charge increases proposed. There is also a cost of living adjustment that equals the increase in the consumer price index for the 12 months in calendar year 2024.
- Mr. Shealy said the budget is a living, breathing number that can be worked with during the year, as needed. He said he thinks it is a good budget going in.
- Mr. Johnson asked if there is a proviso for the elected officials that states they will get the cost of living adjustment, as well.
 Mr. Shacker said that is in there.
- Mr. Johnson made a motion to accept third reading; Mr. Scurry provided the second.
- Mr. Johnson commended the job for the incredible job of holding the line and not increasing taxes, in an economy like this, and to provide these services, is just phenomenal. He said hats off to his fellow council members and staff. He said he knows it took a lot, but he thinks it is the right thing to do for residents as they are feeling the pinch of this economy, and he is thankful they were able to do this.
- Mr. Fulmer said their fiscal year runs July 1 through June 30, and there is a requirement to have a budget in place by July 1 so that the county is fiscally responsible for their expenses going forward. He said there is a need have these approvals and readings take place on a certain time frame in order to get those in place by July 1. However, he said this is a working

document and if there are any problems with the budget, he said Administrator Shacker is graciously committed to try and address those concerns and if need be, they can come back and amend the budget at a later date. He said it is a living document and it is not end all be all after third reading. He also thanked staff for their efforts to put the budget together.

- Mr. Smith thanked staff for working hard on the budget.
- The motion carried 6-0.

 - Ms. Robbiette Hazel said one thing that was important to her, she said she would like before the budget for council to consider, next year, an opportunity for residents to as questions and get answers, like a forum. Mr. Shealy said the work sessions are designed to be as such, if he is correct. Mr. Johnson said plus the public hearing is an opportunity to do so, as well. Ms. Hazel also said she has a concern of a department and was going to give out, in an envelope, a copy of a particular employee's W2, and what she is making. She said she wants them to look at that, and at the next meeting, look at this particular employee. She said she thinks something is not right there, and there is not an understanding of how her salary and her pay work. She said from what she remembers, you cannot have, and she may be wrong, a part time, salaried employee. She also said that particular department had grant money, and she understands the grant money came in and that money has been paid out in the

- budget money and she listed that out. She said she doesn't understand what they are doing with the funds that are budgeted, that's now being moved over to take care of the grant money.
- Mr. Jerry Reno, of Goggans Road, said he hopes they are going to get their road paved, and it has been an ongoing issue for over 20 years. Mr. Reno said that Mr. Shacker said that possibly next year, they will come into some money to pave their road in the fiscal 2025 budget. He said they had one road out of their subdivision paved and all of them were supposed to be taken in and paved, but something happened in interim, and 20 years has gone by, and they still haven't gotten it paved. He said they have a lot of information. and they have gotten that information out to Senator Cromer, and he doesn't know what else they can do. He said he knows the 2007 is an issue, but he went to the S.C. Attorney General's Office, they are exempt from that ordinance because they bought their property prior to that ordinance. He said he does not know what they can do to get it paved, but they are willing to do what they can to get it paved. Mr. Shealy asked if this was the same road that they asked the CTC to look into. Mr. Shacker said they are formulating a plan, and he will talk with Mr. Reno after the meeting.

- Mr. Shacker provided a CPST update, he said at the July 2, 2025, meeting will be recommendation for bids on the Little Mountain Reunion Park improvements. The second project will be half of the museum scope of work, specifically for HVAC, the other half of that project is the roof, and it has been assessed, and an architect is working to design a solution.
- Mr. Shacker said some things changed at the federal level related to federal funding, and that caused a few funding items for the county to be paused. He said some of those have resumed, including the Safe Streets for All funding.

A RESOLUTION

DECLARING THE INTENTION OF NEWBERRY COUNTY, SOUTH CAROLINA TO REIMBURSE ITSELF FOR CERTAIN EXPENDITURES WITH THE PROCEEDS OF A GENERAL OBLIGATION BOND TO BE INCURRED BY NEWBERRY COUNTY, SOUTH CAROLINA

WHEREAS, Newberry County, South Carolina (the "County") intends to purchase certain public works equipment, including one tri-axle dump truck, one 20-25 ton equipment trailer, and one utility truck with a dump body (herein, the "Equipment"); and

WHEREAS, the total cost the Equipment is expected to be approximately \$400,000; and

WHEREAS, the County presently intends to issue a \$405,000 general obligation bond of the County (the "Obligation") to defray the cost of the Equipment; and

WHEREAS, the County reasonably expects that a portion of the expenditures incurred for the Equipment will be paid prior to the issuance of the Obligation; and

WHEREAS, the County intends and reasonably expects to reimburse itself for all such expenditures paid by it with respect to the Equipment prior to the issuance of the Obligation from the proceeds of the Obligation and such intention is consistent with the budgetary and financial circumstances of the County, such expenditures to be made from the General Fund of the County; and

WHEREAS, all of the costs to be paid or reimbursed from the proceeds of the Obligation will be for costs incurred in connection with the issuance of the Obligation or will, at the time of payment thereof, be properly chargeable to the capital account of the Equipment (or would be so chargeable with a proper election) under general federal income tax principles.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF NEWBERRY COUNTY, SOUTH CAROLINA, IN MEETING DULY ASSEMBLED:

- Section 1. It is hereby declared that the facts set forth in the preambles to this Resolution are in all respects true and correct.
- Section 2. It is hereby declared that the County intends and reasonably expects to reimburse itself with the proceeds of the Obligation for expenditures for the acquisition of the Equipment paid prior to the issuance of the Obligation.
- <u>Section</u> <u>3</u>. This Resolution shall constitute a declaration of official intent under United States Department of the Treasury Regulation Section 1.150-2.
- Section 4. The Equipment consists of one fire engine, two ambulances, two heart monitors and two CPR devices.
- Section 5. The maximum principal amount the Obligation expected to be issued to defray, among other things, the cost of the Equipment is \$400,000. The maximum principal amount of proceeds of the

Obligation to be reimbursed to the County for Equipment costs incurred prior to the issuance of the Obligation is \$405,000.
Section 6. This declaration shall be made publicly available immediately at the office of the County Council of Newberry County and shall remain publicly available at such offices until the Obligation is issued.

AN ORDINANCE ACTING ON A REQUEST TO AMEND THE OFFICIAL ZONING MAP ESTABLISHED PURSUANT TO ZONING ORDINANCE NO. 12-24-01 AS REVISED AND AMENDED BY ZONING ORDINANCE NO. 6-11-16 AND CODIFIED IN CHAPTER 153 OF THE NEWBERRY COUNTY CODE OF ORDINANCES, ESTABLISHES ZONING CLASSIFICATION AND DISTRICTS SO AS TO REZONE ONE (1) REAL ESTATE PARCEL TOTALING THREE AND TWENTY-FIVE THOUSANDTHS (3.025) ACRES DESIGNATED AS TMS NO. 651-43 FROM GCGENERAL COMMERCIAL TO R2-RURAL.

WHEREAS, Zoning Ordinance, codified in Chapter 153 of the Newberry County Code of Ordinances, establishes zoning classifications and districts, as well as an Official Zoning Map; and

WHEREAS, said Zoning Ordinance provides procedures for the amendment of both the text of the Ordinance and the district boundaries shown on the Official Zoning Map; and

WHEREAS, pursuant to the procedures established by the Zoning Ordinance, application was made for a map amendment to rezone one (1) real estate parcel totaling three and twenty-five thousandths (3.025) acres located at 79 Rader Road, Prosperity, to R2-Rural from GC-General Commercial. Tax Map No. 651-43 is currently vacant land. The Comprehensive Plan shows the future land use for this area to be within the lake development projected area. The Planning Staff does recommend that this real estate parcel be rezoned to R2-Rural.

WHEREAS, the Newberry County Joint Planning Commission, in case number MA01-05-20-25, had this matter on its agenda and considered this request and received comments as to both the existing and intended uses of the property.

The Joint Planning Commission determined that it does concur with the recommendation of the Planning Staff. The Planning Commission has now forwarded its report on the rezoning request to Newberry County Council, as required by law, for consideration of its actions by Newberry County Council.

WHEREAS, Newberry County Council is familiar with the site and the existing uses of the properties located at 79 Rader Road, Prosperity.

NOW, THEREFORE, Newberry County Council makes the following findings of fact and law as to the merits of the rezoning request concerning Tax Map No. 651-43 totaling three and twenty-five thousandths (3.025) acres located at 79 Rader Road, Prosperity as more particularly shown on the plat accompanying the submitted "Official Zoning Map Amendment Application" included in the submitted Planning Commission report attached hereto, R2-Rural from GC-General Commercial.

- A. That the proposed map amendment does promote the implementation of the Comprehensive Plan in the area.
- B. This amendment is needed because the proposed development cannot be accomplished by the owner under the existing zoning district regulations.
- C. That traffic patterns in the neighborhood will not be adversely affected by the change in zoning.

NOW, THEREFORE, BE IT ORDAINED that:
