- Mr. Shealy was elected as the 2026 Chair by a vote of 7-0.

6. Ordinance No. 11-05-2025. An Ordinance authorizing the execution and delivery of a fee agreement by and between Newberry County, South Carolina and Duke Energy Carolinas, LLC, providing for a payment of a fee in lieu of taxes, providing special source revenue credits, and addressing other matters related thereto.

 - Prior to the Public Hearing, Mr. Scurry left the meeting.
 - Mr. Shealy declared the Public Hearing open; with no one signed up to speak, he declared the Public Hearing closed.
- b. Third Reading.
 - Mr. Sease made a motion to accept third reading; Mr. Smith provided the second and the motion passed 6-0.

7. Ordinance 12-01-2025. An Ordinance acting on a request to amend the official Zoning Map established pursuant to Zoning Ordinance No. 12-24-01 as revised and amended by Zoning Ordinance No. 6-11-16 and codified in Chapter 153 of the Newberry County Code of Ordinances, establishes zoning classification and districts so as to rezone one (1) real estate parcel totaling eighty hundredths (.80) acres designated as TMS No. 640-88 from RS-Single Family to R2-Rural.

- a. Public Hearing.
 - Mr. Shealy declared the Public Hearing open; with no one signed up to speak, he declared the Public Hearing closed.
- b. Second Reading.
 - With there being no changes to the Ordinance, Mr. Sease made a motion to accept second reading; Mr. Reeder provided the second and the motion carried 6-0.

8. Consideration and award of a contract for engineering and consulting services for the Newberry County – Safe Streets and Roads For All (SS4A) Planning and Demonstration Project (RFQ Number 2025-14).

- Mr. Shacker said that Newberry County applied for a grant about a year ago from the South Carolina Department of Transportation in the Safe Streets For All program. Once you obtain the planning grant, which the

county was awarded, you develop a plan that you could then pursue implementation money to implement recommendations within the plan.

- The estimated cost of the project was \$300,000, Newberry County was awarded a \$240,000 grant from USDOT and the \$60,000 match was provided by CTC.
- A solicitation was issued to hire an engineering and consulting service, four staff members were asked to evaluate the qualifications of the four submissions. Mr. Shacker said all four were well positioned to do the project and the committee had a difficult assignment to rate them.
- The committee identified two firms they thought would do well and invited them in for interviews.
- Staff recommended Kimley Horn as the highest ranked firm.
- Mr. Shealy asked which firm the City of Newberry chose as they are also participating in the program. Mr. Shacker said their firm did not submit for Newberry County, but they are a subconsultant for another firm who submitted.
- Mr. Smith made a motion to accept the recommendation from staff and go with Kimley Horn for the engineering and consulting services; Mr. Fulmer provided the second and the motion carried 6-0.

9. Consideration of a motion to adopt the proposed 2026 County Council Committee Meeting Schedule.

- Mr. Reeder made a motion to adopt the proposed 2026 County Council Committee Meeting Schedule; Mr. Sease provided the second and the motion carried 6-0.

- Mr. Johnson made a motion to adopt the proposed Newberry County FY 2026-27 Budget Calendar; Mr. Smith provided the second and the motion carried 6-0.

- Mr. Johnson made a motion to offer the position of County Administrator and ratify the employment contract that had been drawn up and negotiated by Ms. Winters for Mr. William Luckadoo; Mr. Smith provided the second and the motion carried 6-0.
- Mr. Luckadoo said he is grateful and appreciative that Newberry County Council is putting into him to come and serve in such a high capacity. He said being an administrator, which he has been for around 11 years, is not an easy role and it is not easy to come into a new environment and take on an administrative role. He said he was excited to come in, and he did his due diligence with Newberry County to make sure it was a fit for him. He said he has spent most of his life in Batesburg-Leesville and he is no stranger to Newberry County. He said he looks forward to the opportunity, educated himself on the things council has recently done, and what is in place, and he has heard what will be coming down the road.
- Mr. Shealy said they look forward to Mr. Luckadoo joining their team, and they are sad to see Mr. Shacker go, but look forward to working with Mr. Luckadoo.

14. Comments/Requests from County Administrator.

- Mr. Shacker said they have a lot of projects going on; he said the Mawson's Way project is underway and very good progress is being made and the estimated completion date is March 20. He said the Mid-Carolina Commerce Park II Phase 3B, water and sewer project, they have the water in and there will soon be testing and sewer starting after that, with completion date estimated as July 10.
- The Department of Commerce had funding for economic development set aside in the amount of \$80 million for site enhancement projects; Newberry County was able to secure \$3 million. This will be used to extend the road in the Mid-Carolina Commerce Park II – mirroring the water and sewer that is being laid into the park now, and to pad out site six.
- Roof bids came in for the Newberry Museum (CPST Project) there were four bidders and they look good. There should be a recommendation at the next meeting, all four are within budget.
- The FY 2026-27 budget process is underway, the instruction memo was sent out, and department heads are preparing their budgets.
- Regarding FEMA reimbursements, Mr. Shacker said the flow of money has begun and they have had about \$400,000 being reimbursed.

- Mr. Smith thanked the stations coming out and their hard work. He also thanked employees for their hard work and told Mr. Luckadoo that he looks forward to working with him. He reminded everyone about the upcoming Martin Luther King Parade on Jan. 18th and other activities.
- Mr. Reeder said it is good to see a full house and hopefully that will happen the rest of the year. He said they look forward to everyone's opinion, and he hopes the people here and the people watching at home come to meetings because what they try to do is listen to what residents say and do what they want them to do. Mr. Reeder said this is the 25th year he has been working on a Martin Luther King Day program in Newberry County.

AN ORDINANCE ACTING ON A REQUEST TO AMEND THE OFFICIAL ZONING MAP
ESTABLISHED PURSUANT TO ZONING ORDINANCE NO. 12-24-01 AS REVISED
AND AMENDED BY ZONING ORDINANCE NO. 6-11-16 AND CODIFIED IN
CHAPTER 153 OF THE NEWBERRY COUNTY CODE OF ORDINANCES,
ESTABLISHES ZONING CLASSIFICATION AND DISTRICTS SO AS TO REZONE
ONE (1) REAL ESTATE PARCEL TOTALING EIGHTY HUNDREDTHS (.80) ACRES
DESIGNATED AS TMS NO. 640-88 FROM RS-SINGLE FAMILY RESIDENTIAL TO R2-
RURAL.

WHEREAS, Zoning Ordinance, codified in Chapter 153 of the Newberry County Code of Ordinances, establishes zoning classifications and districts, as well as an Official Zoning Map; and

WHEREAS, said Zoning Ordinance provides procedures for the amendment of both the text of the Ordinance and the district boundaries shown on the Official Zoning Map; and

WHEREAS, pursuant to the procedures established by the Zoning Ordinance, application was made for a map amendment to rezone one (1) real estate parcel totaling eighty hundredths (.80) acres located at 178 Mt. Tabor Road, Little Mountain, to R2-Rural from RS-Single Family Residential. Tax Map No. 640-88 is currently vacant land. The Comprehensive Plan shows the future land use for this area to be within the transitional projected area. The Planning Staff does recommend that this real estate parcel be rezoned to R2-Rural.

WHEREAS, the Newberry County Joint Planning Commission, in case number MA01-11-18-25, had this matter on its agenda and considered this request and received comments as to both the existing and intended uses of the property.

The Joint Planning Commission determined that it does concur with the recommendation of the Planning Staff. The Planning Commission has now forwarded its report on the rezoning request to Newberry County Council, as required by law, for consideration of its actions by Newberry County Council.

WHEREAS, Newberry County Council is familiar with the site and the existing uses of the properties located at 178 Mt. Tabor Road, Little Mountain.

NOW, THEREFORE, Newberry County Council makes the following findings of fact and law as to the merits of the rezoning request concerning Tax Map No. 640-88 totaling eighty hundredths (.80) acres located at 178 Mt. Tabor Road, Little Mountain as more particularly shown on the plat accompanying the submitted “Official Zoning Map Amendment Application” included in the submitted Planning Commission report attached hereto, R2-Rural from RS-Single Family Residential .

A. That the proposed map amendment does promote the implementation of the Comprehensive Plan in the area.

B. This amendment is needed because the proposed development cannot be accomplished by the owner under the existing zoning district regulations.

C. That traffic patterns in the neighborhood will not be adversely affected by the change in zoning.

NOW, THEREFORE, BE IT ORDAINED that:

ORDINANCE NO. 01-01-2026

**AN ORDINANCE AMENDING THE TEXT OF THE OFFICIAL ZONING ORDINANCE
OF NEWBERRY COUNTY, SOUTH CAROLINA, AS CODIFIED IN CHAPTER 153 OF
THE CODE OF ORDINANCES OF NEWBERRY COUNTY, SOUTH CAROLINA BY
AMENDING SECTION 153.033, FENCES AND WALLS, SECTION 153.168, SETBACK
FROM THE LAKE SHORE, SECTION 153.170 STRUCTURES AND PROJECTIONS
INTO REQUIRED YARDS AND RIGHTS-OF-WAY, AND SECTION 153.231
DEFINITIONS.**

WHEREAS, the County of Newberry (the “County”) is a political subdivision of the State of South Carolina; and

WHEREAS, Newberry County Council (the “Council”) is the duly elected governing body of the County of Newberry; and

WHEREAS, the Council is vested with the authority to amend, delete, or create ordinances that are in the best interest of the County pursuant to Section 4-9-30 et al of the South Carolina Code of Laws, 1976, as amended; and

WHEREAS, it has been determined by the Council that certain sections of the Zoning Ordinance of Newberry County were in need of review and amendment.

The following sections of the County Code of Ordinances have proposed amendments:

SECTION 1. The Newberry County Code of Ordinances, Title XV Land Usage, Chapter 153, Zoning Code, Section 153.033, Fences And Walls is amended as follows:

§ 153.033 FENCES AND WALLS.

(A) *In general.* The following standards shall apply to all fences and walls in all zoning districts unless otherwise noted.

- (1) Fences and walls shall be maintained in good order by the owner.
- (2) Fences shall not contain advertising, signs, or logos on the exterior of the fence unless deemed necessary by the Zoning Administrator.
- (3) Fences and walls shall be installed and maintained so as not to interfere with the sight distance requirements of this chapter or the sight distance needs of drivers in parking areas, at entrance and exit locations, and at street intersections.

- (4) Fences and walls shall be constructed such that the "finished" part of the fence or wall is located to the exterior of the property.
- (5) Nothing in this subsection shall preclude the installation of temporary fences around construction works, erected or maintained pursuant to the Building Code, soil erosion and sedimentation requirements, or tree conservation requirements.
- (6) **Fences and walls shall be allowed within the setback area as identified in §153.170 (C).**

SECTION 2. The Newberry County Code of Ordinances, Title XV Land Usage, Chapter 153, Zoning Code, Section 153.168, Setback From The Lake Shore is amended as follows:

§ 153.168 SETBACK FROM THE LAKE SHORE.

All principal and accessory structures shall be set back no less than 50 feet from the 360 contour line 1929 National Geodetic Vertical Datum (NGVD) on Lake Murray and the 440 contour line on Lake Greenwood, with the exception of fences and walls. However, where adjacent lake properties on both sides of a property are developed, the setback shall not be less than the average of the setback from the 360 contour on Lake Murray or the 440 contour on Lake Greenwood of the principal structures on the adjacent lake properties. Mapping and survey data as provided by the Newberry County Geographic Information System (GIS) will be used by the Zoning Administrator to determine the original location of the 360 or 440 contour lines. Local, state, or federal setback requirements from the lake shore may also apply.

SECTION 3. The Newberry County Code of Ordinances, Title XV Land Usage, Chapter 153, Zoning Code, Section 153.170, Structures And Projections Into Required Yards And Rights-Of-Way is amended as follows:

§ 153.170 STRUCTURES AND PROJECTIONS INTO REQUIRED YARDS AND RIGHTS-OF-WAY.

- (A) No principal building or structure shall be located within any required setback or yard.
- (B) No principal building or structure shall be located within any required buffer.
- (C) Permitted fences and walls, retaining walls, security gates, paths, walkways, handicap ramps, mailboxes, utility poles, signs, lighting fixtures, patios at grade, and similar features may be located in a required setback or yard, including the lake shore setback, so long as the sight triangle on corner lots and at driveway intersections is protected.
- (D) Ornaments, eaves, cornices, gutters, window sills, awnings, canopies, and other minor architectural features projecting less than 18 inches from the main portion of a building shall be allowed to project into any required yard or setback.
- (E) Steps and open porches without roofs shall be permitted in any required yard or setback.

- (F) Permitted signs may be placed in required yards and setbacks per the requirements set forth in §§ [153.213](#) *et seq.* - Signs. However, permitted signs may not extend into or over any existing public right-of-way.
- (G) In GC and IND Districts, guard/entry structures, vehicle scales, and roofs over such structures and devices are permitted within required front yards, provided that they do not constitute a substantial impediment to visibility across the yards which would contribute to the creation of traffic hazards, and further provided that servicing operations in connection therewith can be conducted so as not to interfere with public use of adjacent sidewalks or public streets.
- (H) Above-ground sewer backflow prevention devices are expressly prohibited in the established front yards of buildings.

SECTION 4. The Newberry County Code of Ordinances, Title XV Land Usage, Chapter 153, Zoning Code, Section 153.231, Definitions is amended as follows:

§ 153.231 DEFINITIONS.

STRUCTURE. Anything constructed or erected, the use of which requires location on the ground, or attachment to something having location on the ground, including for purposes of this chapter buildings, mobile manufactured homes, travel trailers, signs, swimming pools, **fences**, and antennae, but excluding from definition as structures minor landscaping features such as ornamental pools, planting boxes, bird baths, paved surfaces, walkways, driveways, **fences and walls**, recreational equipment, flagpoles, and mailboxes.

SECTION 5. Conflicting Ordinances. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
