February 7, 2022

The Newberry County Voter Registration and Election Board met on Monday, February 7, 2022, at 1:00 PM at the Newberry County Registration and Election Office.

Chairman John Glasgow called the meeting to order, and Henry Summer gave the invocation.

Board Members present were Chairman John Glasgow, Vice-Chairman Brenda Fulmer, Doretha Simpson, and Martha Waller. Director Amy Perkins was also in attendance. Secretary Sam Price and Donnie Bobb were absent.

Chairman John Glasgow asked for a motion to approve the minutes from the January 10, 2022, board meeting. Doretha Simpson made the motion to defer the minutes. Martha Waller seconded, and the motion to defer the minutes was approved unanimously.

Director Amy Perkins reminded everyone to file their Statement of Economic Interests (SEI) Report. All reports are due by March 30, 2022.

Director Perkins let everyone know the budget had been sent to county administration earlier in the week. Amendments, if necessary, would be made at a later date. Monies had been added to the budget to allow three board members and the director to attend the 2023 SCARE Conference and for two people to attend the Mid-Year SCARE Conference.

The SCARE Regional Work Conference will be held in Beaufort SC on April 10-12. Chairman John Glasgow appointed Doretha Simpson to attend the Regional Work Conference and Brenda Fulmer to serve as an alternate. It was the consensus of the board to accept Chairman John Glasgow's appointment.

Director Perkins let the board members know everyone was signed up for the April 26, 2022, State Election Commission Zoom Class, *Getting Things Done Under Pressure*, 9:00 AM to Noon. The classes will be held in County Council Chambers.

Director Perkins informed the board members as of the current date, she did not have all of the necessary files to complete the redistricting, but had already completed SC Congressional Redistricting. She would let them know when she receives the additional files to complete redistricting. She did not have a firm date.

There being no further business, Chairman John Glasgow asked for a motion to adjourn. Doretha Simpson made the motion to adjourn seconded by Martha Waller. The meeting adjourned at 1:30 PM. The next meeting will be held on Monday, March 7, 2022, at 1:00 PM.
