AN ORDINANCE AMENDING AN ORDINANCE ENTITLED "AN ORDINANCE TO PROVIDE

OTHER MATTERS RELATING THERETO" TO AMEND THE USE OF A PORTION OF THE

PROCEEDS OF THE BONDS AUTHORIZED THEREBY

BE IT ORDAINED BY COUNTY COUNCIL OF NEWBERRY COUNTY, SOUTH CAROLINA, IN MEETING DULY ASSEMBLED AS FOLLOWS:

ARTICLE I

FINDINGS OF FACT

Section 1.01

As an incident to the adoption of this ordinance, Newberry County Council (the "County Council"), the governing body of Newberry County, South Carolina (the "County"), finds that the facts set forth in this Article exist, and the statements made with respect thereto, are true and correct:

- 1. Pursuant to an ordinance entitled "An Ordinance To Provide For The Issuance And Sale Of Not Exceeding One Million Two Hundred Fifty Thousand Dollars (\$1,250,000) General Obligation Bonds Of Newberry County, South Carolina, For The Issuance Of Notes In Anticipation Of Such Bonds, To Prescribe The Purposes For Which The Proceeds Of Such Obligations Shall Be Expended, To Provide For The Payment Thereof, And Other Matters Relating Thereto," enacted November 20, 2019 (the "Ordinance"), the County Council authorized the issuance of the \$325,000 General Obligation Bond, Series 2020A, of the County (the "Bond").
- 2. Pursuant to the provisions of the Ordinance, a portion of the proceeds of the Bond (the "Proceeds") were to be used for the purchase and upfit of the Jacobs Building in Newberry for use by the County (collectively, the "Improvements").
- 3. The Council has been advised that the County will be unable to purchase the Jacobs Building and has determined to allocate the proceeds of the Bonds intended for the Improvements to other purposes (herein, the "New Improvements"), to wit:

ARTICLE II

AMENDMENT OF ORDINANCE

Section 2.01

Exhibit of the Ordinance is amended, striking therefrom references to the Improvements and replacing with the items described as the New Improvements, as described in Article I herein.

Section 2.02

The Ordinance, as amended by Section 2.01 herein, shall continue of full force and effect.

ARTICLE III

PUBLIC HEARING

Section 3.01

Pursuant to the provisions of Section 4-9-130 of the Code of Laws of South Carolina, 1976, as amended, a public hearing, after giving reasonable notice, shall be conducted prior to the third and final reading of this Ordinance by County Council. In accordance with this provision, a public hearing shall be conducted and due notice shall be provided all as required by said Section 4-9-130. The form of the notice to be published, with such changes as may be approved by the Chairman of the County Council, is attached hereto as Exhibit "A".
