1. Call to Order

a. Project Development

Mr. Farmer reported that we currently have over 20 active projects, most of which are in initial stages, and that he will discuss further in executive session.

b. Product Development

Mr. Farmer spoke about the South Carolina Department of Commerce's LocateSC Site Enhancement Initiative. It is a grant award program that can offer up to \$300,000 towards site enhancement efforts. Mr. Farmer discussed some possible options, to include: furthering the road in the Mid-Carolina Commerce Park, grading of sites in the Mid-Carolina Commerce Park, adding a water tank in the Mid-Carolina Commerce Park, and possible land acquisition. Mr. Adams suggested we apply for the grant to use towards making parcel 14 in the Mid-Carolina Commerce Park "pad-ready." Mr. Farmer will write the letter.

Mr. Farmer reported that the certification for the Mid-Carolina Commerce Park will expire in 2018. He will notify the committee again as the date approaches.

c. Professional Development

Mr. Farmer informed the committee that in July-2017 Kara Cannon will be attending the Basic Economic Developer's Course at UNC-Chapel Hill, and he will be attending the Advanced Symposium.

d. Existing Industry

Mr. Farmer reported that the annual "Toast of the Town" industry appreciation event was a success. We had somewhere in the neighborhood of a hundred attendees.

Mr. Farmer also informed the committee that there are several potential existing industry expansions in the works, to be discussed further in executive session.
