

NEWBERRY COUNTY COUNCIL MINUTES AUGUST 15, 2018 7:00 P.M.

Newberry County Council met on Wednesday, August 15, 2018, at 7:00 p.m. in Council Chambers at the Courthouse Annex, 1309 College Street, Newberry, SC, for a regular scheduled meeting.

The meeting was duly advertised as required by law.

Chairman Livingston called the meeting to order at 7:00 p.m.

Scott Cain led the invocation followed by the Pledge of Allegiance.

1. Additions, Deletions, and Adoption of Agenda

Vice Chairman Koon motioned to adopt the agenda as presented; seconded by Mr. Stockman. the vote was unanimous.

2. Personal Appearances

a. Michelle Long, Executive Director Chamber of Commerce – Leadership Class Presentation

Mrs. Long approached the podium and updated Council on the leadership class and shared that there were 21 participants. She recognized Mary Alex Kopp, Colin Shealy, Ken McBride, Kimberly Kitchen, Laura Kneece and Rick Farmer who were in attendance tonight and program

participants. She presented a PowerPoint that captured the participants' experiences throughout the program that was designed to help them understand the assets and challenges of Newberry County in the areas of health and human services, community, education, infrastructure, emergency services, law enforcement, government, economic development, agriculture and art, recreation and tourism. The program was also designed to elevate leadership for future engagement in the community. Mrs. Long said one of the findings of the class was that we are very blessed in Newberry County with the support and services that are available; however, not everyone knows about them or do not know where to find these services. Some of the folks that the group heard from was DSS, Veterans Affairs, Council on Aging, Free Medical Clinic, and Newberry County Memorial Hospital. She said they toured many facilities and heard from a lot of professionals within the program areas. At the conclusion of the class they identified a need in the educational system for those students that fall through the cracks and they would like to start a 501C3 to include afterschool programs, mentorships, summer programs, and teaching entrepreneur and basic soft skills. She said it will take awhile but hopefully they will have a name, vision, and mission and get that off the ground. She thanked council and asked if they had any questions.

Dr. Rucker responded that this was just super and she thanked Mrs. Long and the group for all they have done and will continue to do.

Mr. Reeder said he receives a lot of phone calls at the district office about afterschool programs and mentoring and that will be an excellent program for Newberry County.

Dr. Rucker shared that Ken McBride is an invaluable resource and gets a lot of things done.

Mrs. Long replied that is why she wanted Mr. McBride on her board; he is currently serving on the Chamber of Commerce Board.

Mr. Cain thanked Mrs. Long for taking the Chamber of Commerce to the next level. He said she has started many of these great programs and is bringing a lot of folks together and is building an organization that is helping Newberry County's vision and is making a positive impact. He thanked her for all of her efforts and to the young adults taking advantage of the leadership programs.
