NEWBERRY COUNTY COUNCIL MINUTES FEBRUARY 17, 2021

Newberry County Council met on Wednesday, February 17, 2021, at 6:00 p.m. in Council Chambers at the Courthouse Annex, 1309 College Street, Newberry, S.C., for a regular scheduled meeting.

Mr. Livingston called the meeting to order at 6:00 p.m. and determined all Council Members to be present either in person or via Zoom.

Mr. Johnson had the invocation followed by the Pledge of Allegiance.

1. ADDITIONS, DELETIONS AND ADOPTION OF THE AGENDA

There being no amendments to the Agenda, Mr. Scurry moved to adopt the agenda as presented; seconded by Mr. Shealy. Vote was unanimous.

2. EMPLOYEE RECOGNITION

- 3. ORDINANCE #11-24-20: AN ORDINANCE ACTING ON A REQUEST TO AMEND THE OFFICIAL ZONING MAP ESTABLISHED PURSUANT TO ZONING ORDINANCE #06-11-16, CODIFIED IN CHAPTER 153 OF THE NEWBERRY COUNTY CODE OF ORDINANCES, SO AS TO REZONE ONE REAL ESTATE PARCEL TOTALING FIFTY-TWO AND NINE-TENTHS (52.9) ACRES DESIGNATED AS TMS PARCEL NO. 631-12 (TRACT A) FROM SINGLE FAMILY RESIDENTIAL (RS) AND RURAL (R2) TO SINGLE FAMILY RESIDENTIAL (RSM).

a. Public Hearing

Motion by Mr. Scurry to hold the public hearing; second by Mr. Johnson. Vote was unanimous.

Mr. Livingston declared this to be the public hearing.

- In addition, letters received from Sherree Richardson and Tom Abraham were read into the record.

Mike Satterfield with Great Southern Homes spoke regarding the County's need for housing. They are proposing 88 homes (1.7 houses per acre), If

approved and once construction starts, it will be 3-5 years to go through this procedure.

There being no further comments, Mr. Livingston declared the public hearing closed.

b. Third Reading

Mr. Hipp moved to table third reading at least until the next meeting or possibly the meeting after that. That is up for discussion as to whether to postpone for 2 weeks or 4 weeks.

Mr. Shealy seconded the motion.

Mr. Livingston asked Council if they wanted to determine whether 2 weeks or 4 weeks.

Mr. Shealy preferred 4 weeks. Mr. Hipp agreed with that.

Mr. Livingston stated a motion was on the table to delay third reading for 4 weeks which would be until the March 17th meeting.

However, Mr. Livingston said he would like to see third reading potentially moved to the first meeting in March if a meeting can be set up quickly between the developer and community.

Mr. Shealy said he would get the meeting scheduled as soon as possible.

4. ORDINANCE #02-04-21: AN EMERGENCY ORDINANCE TO SUSPEND TEMPORARILY THE NORMAL OPERATING PROCEDURES APPLICABLE TO THE MEETINGS OF COUNTY COUNCIL, TO DECLARE A STATE OF EMERGENCY WITH REGARD TO COUNTY COUNCIL'S CONTINUED ABILITY TO CONDUCT NECESSARY BUSINESS OF THE COUNTY, TO PROVIDE FOR EMERGENCY PROCEDURES FOR PUBLIC MEETINGS OF COUNTY COUNCIL DURING SAID EMERGENCY, AND TO PROVIDE FOR THE CONTINUATION OF SAID PROCEDURES UPON EXTENSION OF THIS ORDINANCE BY COUNTY COUNCIL.

This is an extension to the ordinance approved by Council on December 30, 2020.

Mr. Hipp moved to approve the ordinance; seconded by Mrs. Arrowood.

Mr. Johnson suggested making this permanent by another ordinance requiring three readings.

There being no further discussion, Mr. Livingston called for the vote.

Vote was unanimous.

5. CONSIDERATION TO APPROVE SPRINGHILL CONSTRUCTION FOR THE FLEET MAINTENANCE SHOP ADDITION IN THE AMOUNT OF \$184,900 - CRYSTAL WALDROP, PURCHASING DIRECTOR.

Mrs. Waldrop recommended approval of the low bid from Springhill Construction in the amount of \$184,900.

Motion by Mrs. Arrowood to approve bid of Springhill Construction; second by Mr. Shealy. Vote was unanimous.

Mr. Shealy moved to appoint Max Crawford to Workforce Savannah; second by Mrs. Arrowood. Vote was unanimous.
