  - Mr. Sease made a motion to adopt the minutes as presented; Mr. Scurry provided the second and the motion carried 7-0.
- 2. Additions, Deletions & Adoption of the Agenda.
  - Mr. Hipp made a motion to adopt the agenda as presented; Mr. Reeder provided the second and the motion carried 7-0.
- 3. Resolution No. 09-2024. A Resolution Honoring Councilman Leslie "Les" Hipp.
  - Mr. Sease made a motion to adopt the Resolution; Mr. Reeder provided the second and the motion carried 6-0, with Mr. Hipp recusing himself from the vote.
  - Mr. Hipp thanked his fellow councilmembers for this honorable Resolution, and he appreciates it immensely.
  - Mr. Hipp said he could not do this without his wife, Mrs. Beth Hipp, who supported him this entire time.
  - Mr. Hipp was presented with a plaque for his years of service to Newberry County.
- 4. Ordinance No. 11-01-2024. An Ordinance to Amend Chapter 91 of the Code of Ordinances of the County of Newberry to Adopt Road and Development Design Standards and Specifications.
  - a. Public Hearing

- Mr. Shealy declared the Public Hearing open, with no one signing up or standing to speak, Mr. Shealy declared the Public Hearing closed.
- b. Second Reading.
  - Mr. Fulmer made a motion to approve second reading; Mr. Hipp provided the second and the motion carried 7-0.
- 5. Ordinance No. 12-01-2024. An Ordinance to Amend Chapter 152 of the Code of Ordinances of the County of Newberry to Adopt Updated Standards for the Reduction of Flood Hazards.
  - a. First Reading.
    - Mr. Sease made a motion to approve first reading; Mr. Fulmer provided the second and the motion carried 7-0.
- 6. Consideration of a motion to adopt the proposed 2025 County Council Meeting Schedule.
  - Mr. Fulmer made a motion to adopt the 2025 County Council Meeting Schedule; Mr. Scurry provided the second.
  - Mr. Sease said usually the first meeting in July they do not have a meeting, but it looks like there is one scheduled for next year; Mr. Shacker answered in the affirmative and said that is what staff was proposing.
  - The motion carried 7-0.

- 7. Consideration and approval of a bid for HVAC Replacements of thirteen units (seven Newberry County locations) (Bid No. 2024-9).
  - Mr. Shacker said this was a project staff proposed the grant application to the S.C. Energy Office, to which council approved. Staff submitted an application for the federal fund for replacement of heating/air units. The scope of the project is 13 units in seven buildings. The project budget that was previously approved \$156,300, \$75,000 of which would be funded via the grant.
  - The lowest bidder was Fulmer Heating and Cooling was under budget at \$104,646, making the local share \$29,646.
  - Mr. Sease made a motion to approve the low bid from Fulmer Heating and Cooling; Mr. Reeder provided the second.
  - Mr. Hipp said he thinks it is good they got these bids in under what they expected, and was glad the lowest bidder was local to the county.
  - Mr. Johnson said he thinks it is good business, and it will save the county money in the long run.
  - The motion carried 7-0.
