 Mr. Smith made a motion to accept the minutes as presented; Mr. Reeder provided the second and the motion carried 7-0.

2. Additions, Deletions & Adoption of the Agenda.

- Mr. Sease made a motion to remove item 4, to include the public hearing and second reading, from the agenda as the petitioner has withdrawn their request for the rezoning. Mr. Scurry provided the second and the motion carried 7-0.
- Mr. Smith made a motion to accept the agenda as amended; Mr. Sease provided the second and the motion carried 7-0.

3. Special Recognition:

- a. Silverstreet Fire Department.
 - Mr. Long recognized the station listed above for their achievements, history and other accolades, as well as highlighting the work they do throughout the year.
 - Mr. Shealy said this is indeed a special recognition and that the county's volunteers were the backbone of Newberry County.
 - Mr. Reeder said he knows they work long hours for low pay and that he appreciates everything they do.
 - Mr. Smith thanked the volunteers for everything they do for the county.
 - Mr. Sease thanked the volunteers for the service they provide Newberry County.
 - Mr. Fulmer said that fire departments are the glue that hold communities together and provide for the

communities they serve, not only through fire service, but in times of needs.

- 4. Ordinance 06-01-2025. An Ordinance acting on a request to amend the official Zoning Map established pursuant to Zoning Ordinance No. 12-24-01 as revised and amended by Zoning Ordinance No. 06-11-16 and codified in Chapter 153 of the Newberry County Code of Ordinances, establishes Zoning Classifications and Districts as to rezone one (1) real estate parcel totaling three and twenty-five thousand (3.025) acres designated as TMS No. 651-43 from GC-General Commercial to R2-Rural.
 - a. Public Hearing.
 - b. Second Reading.
 - Due to the petitioner withdrawing their request to rezone the property, Newberry County Council removed this item from the agenda. If the petitioner wishes to resubmit their request, they will need to start the process over.
- 5. Consideration and approval of the award of a contract for landfill monitoring and reporting services (RFQ 2025-8).
 - Mr. Smith made a motion to accept the highest ranked firm,
 Alliance Consulting Engineers, Mr. Johnson provided the second and the motion carried 7-0.
 - According to Mr. Shacker, Newberry County formerly operated a
 landfill located near Cockrell Drive near S.C. Highway 219 and
 Interstate 26. That landfill was closed a number of years ago.
 Newberry County is required to monitor the landfill and report the
 results of the monitoring activities to the S.C. Dept of
 Environmental Services formerly SCDHEC. The county has for a
 number of years engaged consulting engineers to perform the
 monitoring and to prepare the required reports to SCDES. The
 current contract is set to expire.

- County staff solicited proposals from qualified consultants to provide landfill monitoring and reporting services to the county.
 County staff reviewed those proposals and ranked them using the scoring criteria set forth in the request for proposals. Based on the rating process, county staff recommends that County Council award the contract to Alliance Consulting Engineers.
- 6. Consideration and approval of a bid for Little Mountain Reunion Park Improvements, a 2022 CPST Project (Bid Number 2025-9).
 - Mr. Sease made a motion to accept the low bid from Sossamon Construction Company in the amount of \$1,533,000; Mr. Reeder provided the second and the motion carried 7-0.
 - The Little Mountain Reunion Park Improvements is a 2022 CPST Project. The approved bid is not only under the revised budget, but also the balloted amount for the project, this amount also includes the alternates for the project. The alternates include replacing asphalt with concrete and relocating the flagpole(s).
- 7. Consideration and approval of bids for Newberry Museum HVAC Replacements, a 2022 CPST Project (Bid Number 2025-13).
 - Mr. Smith made a motion to accept the low bid from Walker White in the amount of \$300,003; Mr. Scurry provided the second and the motion carried 7-0.
 - This is another 2022 CPST project, this bid was for part of the museum project, specifically HVAC replacement. Another bid will be forthcoming that will address the roof at the Newberry Museum. Newberry County, at this time, projects the total will be under budget.

- 8. County Council may take action on matters discussed during the 5:00 pm executive session.
 - Mr. Sease made a motion to authorize the County Administrator to execute the agreement between Newberry Hospital and Newberry County for EMS services; Mr. Reeder provided the second and the motion carried 7-0.
 - Mr. Sease made a motion to authorize the County Administrator to enter into a Letter of Intent to option property owned by the County in anticipation of the economic development project's consideration of Newberry County (Project Altair); Mr. Fulmer provided the second and the motion carried 7-0.
