Call to Order-Invocation

Mr. Carroll called the meeting to order, and Mr. Werts led the invitation.

2. Approval of Minutes from Prior Meeting

Financial Report from Treasurer

Mr. Cannon reported that the cash balance for March 31, 2025, was \$6,243,835.80. The funds received were \$174,437.81. Total withdrawals were \$100,00.00. The total cash balance is \$6,518,273.61. Total funds committed are \$4,909,109.79 and the uncommitted balance is \$1,609,163.82.

Mr. Cannon reported that the cash balance for proviso (118.19) was \$3,666,545.13. Total withdrawals were \$21,712.26. The total cash balance is \$3,644,832.87. Total funds committed are \$3,644,832.87.

Mr. Cannon reported that the cash balance for proviso (118.20) was \$318,000.

Mr. Cannon reported that the cash balance for proviso (118.22) was \$3,172,100.00.

Motion made to accept as information only. Motion second and all were in favor.

3. Old Business/New Business Old Business

Mr. Rowe said that for the past couple of months he has been trying to get some estimates on paving a few roads, one of which is Henry Longshore Road. I still haven't received anything back from the local companies to which I have talked. I have been on the phone and emailed them, but there is no information yet. I did speak with a gentleman at Stead Paving; they have an ongoing project in the county. I talked to him, and he said as soon as I could give him the information, he would get back to me soon. Unfortunately, we still don't have any estimates to go by. I am hoping to have information in a week or two.

New Business

Mr. Rowe said that he would like for the committee to consider funding to pave the entrances at the recycling centers county wide. I talked to Jeremy and a lot of the roads they are paving, for example, Seibert Road that goes by one of the centers, you have a nice, paved road but then it just drops off onto a gravel drive. Over time it can damage the sides of the road. I think it would look a lot more presentable to the public.

Mr. Carroll asked Mr. Rowe if he had a price on this.

Mr. Rowe said he didn't yet. I just wanted to bring it up for discussion to see if it is something the committee would consider. We have twelve recycling centers in the county.
