1. Call to Order and Invocation

6. Discussion of Forestry Award Grants-Tommy Long, Emergency Services Coordinator

Tommy Long reported the Forestry grant is a 50/50 matched grant for \$15,402.00 for Whitmire, Consolidated and Silverstreet Fire Departments. He stated it will be matched within the fire budget. The Committee approved as information only.

7. Discussion of Fire and Rescue Reporting Software Contract Award- Tommy Long, Emergency Services Coordinator

Tommy Long reported only one vendor responded. The price quoted is \$51.535.00. This system will keep reports fire and rescue for state reporting, training records, report CAD's, mapping and inventory. Each department can keep up with their own reporting. Chairman Koon recommended to full council. The recommendation was passed with all in favor.

8. Discussion of Courthouse Water Mitigation Site Work- Ervin West, Facilities Manager

Ervin West reported water is still coming in the basement of the courthouse. One of the options of stopping this is cutting down all of the trees surrounding the courthouse. He advised this would have to go before the ARB before they can do this. Councilman Reeder made a motion to proceed to ARB then to Council. Councilman Waldrop seconds; the motion was unanimous.
