### **New Business:**

MA01-08-21-18: A rezoning request for one(1) one and eighty-seven hundredths (1.87) acres real estate parcel and an abutting one (1) one and twenty-seven hundredths (1.27) acres real estate parcel to be rezoned from RS-Single Family residential to R2-Rural. The properties are at 1409 Civitan Road and north of this address near the intersection of SC Hwy 76, Newberry, SC Tax Map # 339-1-1 and 339-1-2

Anne Peters presented the case to the Planning Commission as outlined in the Planning Staff Report. She advised the Commissioners of the location of the parcel in question by using the GIS aerial map. She stated that the applicant is requesting this rezoning to R2-Rural for future Rural development. After a lengthy discussion with the applicant, and with various pertinent questions from the planning commissioners, Commissioner Chris Cromer made a motion to approve the rezoning request, seconded by Commissioner Benji Vinson. The vote was unanimous to approve the request.
