#### 1. Call to Order and Invocation.

Mr. Koon called the meeting to order at 5:15 p.m. followed by the invocation.

# 2. Election of Chairman 2019 - Wayne Adams, County Administrator.

Mr. Long requested consideration of an ordinance requiring businesses to install KNOX boxes. In case of a fire, this would allow Fire Departments access without waiting for someone to bring a key or the firemen destroying the door to the business. Discussions were held as to costs to businesses and who would have access to the key for each KNOX box.

Mr. Tothacer addressed the committee in further detail as to these issues and requested that the committee obtain additional information before making any decision.

The committee concurred that additional information was needed before reaching a decision.

# 6. Aubrey Horne, Fire Board Chairman.

Mr. Horne reviewed proposed budget requests from the Board of Fire Control for the 2019-2020 budget. The proposed budget requests total approximately \$1 million.

Discussions were held regarding possible ways to generate funds to assist the Board of Rural Fire Control with the items needed.
