They also discussed the possibility of the Coroner's Office obtaining use of an EMS truck that has been taken off line in Pomaria.

Mr. Adams advised them to request placement on the agenda for the May 13 Budget Work Session relating to the pill counter and laptop computers.

5. Aubrey Horne, Board of Rural Fire Control Chairman.

Mr. Horne updated the Committee on equipment requests for the Board of Rural Fire Control for FY 19-20. The top three priorities would be PPE, Pumper/Tanker and Training Grounds.

He also requested designation of training grounds for the Board of Rural Fire Control.

Dr. Rucker moved to recommend the Fairgrounds property as training grounds for the Board of Rural Fire Control; second by Mr. Scurry. Vote was unanimous. This will be presented to the full Council for consideration.
