**Financial Report from Treasurer**

Mr. Cannon reported that the cash balance for September 30, 2025, was \$6,170,092.59. The funds received were \$215,880.79. Total withdrawals were \$145.20. The total cash balance is \$6,385,828.18. Total funds committed are \$3,921,781.96 and the uncommitted balance is \$2,464,046.22.

Mr. Cannon reported that the cash balance for proviso (118.19) was \$1,724,002.51. Total withdrawals were \$647,156.95. The total cash balance is \$1,076,845.56. Total funds committed are \$1,076,845.56.

Mr. Cannon reported that the cash balance for proviso (118.20) was \$318,000.

Mr. Cannon reported that the cash balance for proviso (118.22) was \$3,172,100.00.

### **3. Old Business/New Business**

#### **Old Business**

Mr. Carroll said that the city of Whitmire has requested additional funding of \$20,000 for asphalt and gravel.

Mr. Carroll asked if any other municipalities needed any additional funding.

Mr. Hamm said that Prosperity could use \$10,000.

Mr. Carroll asked for a motion to approve the requests.

Motion was made, motion seconded and all approved.

Mr. Carroll said that the estimate for Langford Mill Road came in cheaper than he thought. The estimate is \$102,805. If we pass this, we are going to add it to the project that has been approved for Little Mountain and Silverstreet. It will go out at the same time. We approved of \$3,368,222 and will add \$102,805 for a total of \$3,471,027.

Motion was made, motion seconded and all approved.

Mr. Carroll said that the committee approved \$65,000 for Mr. Knight to repair some drainage problems on Hwy 76 and Crowder Road. There is one me area where they have a problem. They can repair this while they are repairing the one on Hwy 76. The request is for an additional \$20,000.

Mr. Knight said they came in under budget for the other two projects. We have \$14,000 left, so I am requesting \$20,000 for that location. It will probably be more than that, but we will cover the rest of the cost.

Motion was made, motion seconded and all approved.

#### **New Business**

Mr. Carroll said that the contract for Mr. Cooper is up this month. We need to decide if we want to extend it to another term. The amount is \$25,000.
