Newberry County is requesting proposals from vendors to provide a portable, digital x-ray machine for the Newberry County Coroner's Office, to be housed at the Newberry County Memorial Hospital.

It is the intent to purchase an x-ray machine to help defray costs associated with postmortem examinations and improve the quality of forensic science services for the County of Newberry.

Funding for the machine will be provided by a grant through the SC Healthcare Coalition; therefore, only the highest quality imaging for forensics will be considered.

The County will review products that meet or exceed the specifications stated herein. Any mention of a brand in this solicitation is for reference only; however, responses shall detail any deviation from the preferred product.

Each response shall provide full details of dimensions, power requirements, recording functions, clarification of images, user interface, security, warranty, software, and product description, with brochure containing pictures of equipment needed to answer this solicitation.

All pricing shall include any component necessary to fully operate the equipment. Applicable sales taxes, delivery, installation and training shall also be included in the cost proposal.


