ADDENDUM ONE Invitation for Bids No.: 2023-1 Community Hall Roof Repairs

The following shall be incorporated as part of the solicitation.

- Ice/watershield will not be installed on the entire roof deck, only around the Cuppola Dome edges. A synthetic underlayment will be used on the entire deck per shingle manufacturers specifications.
- The City of Newberry has been contacted about street closures and they
 have agreed to close McKibben Street from Boyce to Main Street. Several
 parking spaces on Boyce Street and on Main Street may be utilized; however,
 advance notice will need to be given to the City of Newberry by the chosen
 contractor
- The cornice repair is removed from the project and will be addressed later in possible change order if funds are allowable.
- All applicable licenses must be obtained by the City of Newberry, including a business license.
- The gutters will not be included in this solicitation.
- Revised bid form is attached addressing the price per foot on the decking.
